

## Notice of temporary road closure, Steeple Claydon Road

High Speed Two (HS2) is the new high speed railway for Britain. We continually reviewing the works on our construction sites in line with Government and Public Health England (PHE) advice on dealing with COVID-19. The Government's current strategy makes it clear that construction activity can continue as long as it complies with this guidance. Please be assured that only sites that can operate within the guidelines are operational. All sites will remain under constant review. ### What are we doing?

As part of our preparatory works to form the internal haul and access roads, we will be carrying out Ground Investigation (GI) works along a section of Steeple Claydon Road (also known as West Street) in the vicinity of the bridge by Portway Farm.

In order to complete our works safely will need to temporarily close the road for two days, starting Tuesday 7 September. To reduce the inconvenience to road users, this closure will only be introduced during off peak hours.

### When will these works take place?

A section of Steeple Claydon Road will be closed from Tuesday 7 September to Thursday 9 September between 9.00am and 3.00pm, with a diversion in place.

We will work to reopen the roads as soon as possible.

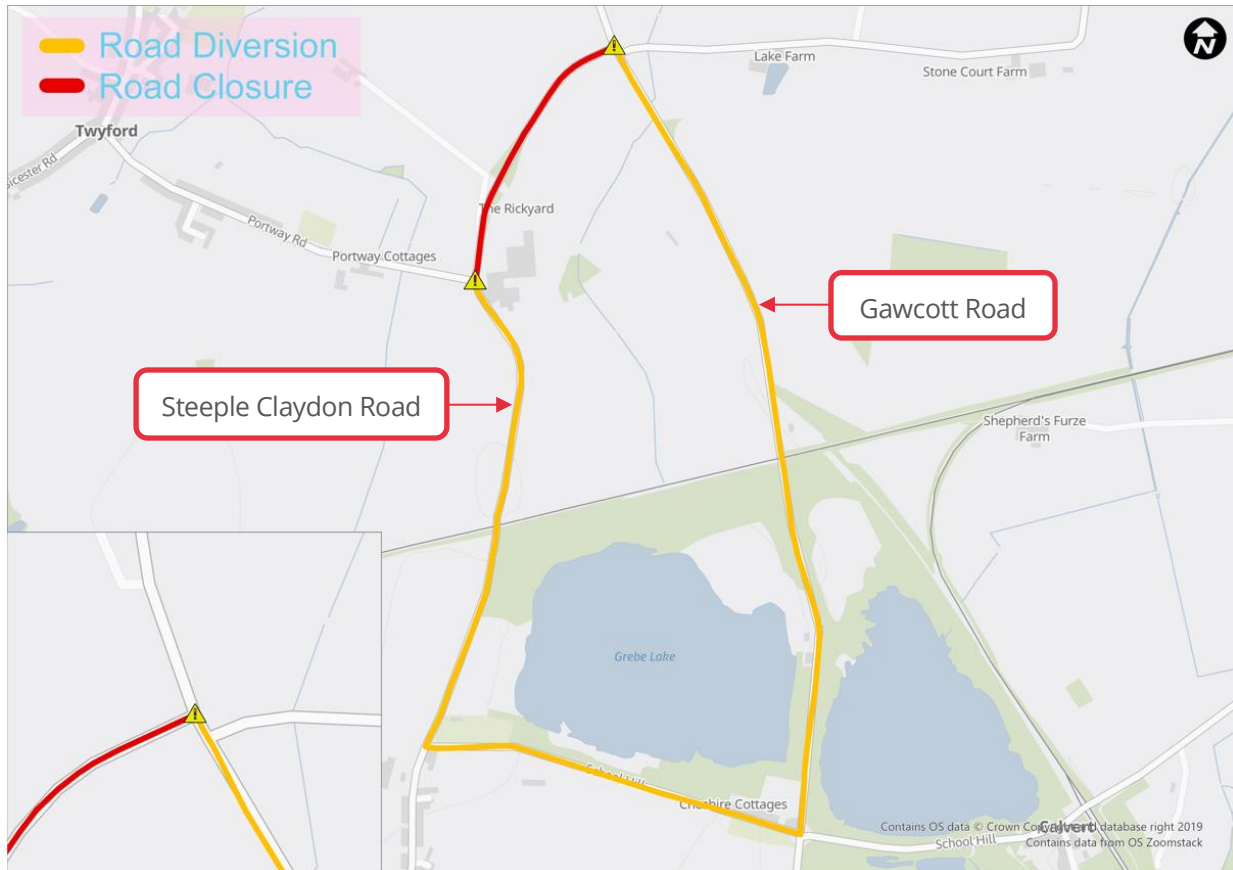
