What are we doing?

In March and April 2023, we will be continuing with utility diversion works on Gawcott Road/Perry hill. This is in preparation for the demolition of Gawcott Road/Perry Hill Bridge this summer.

We will be working on a gas pipe underneath Gawcott Road/Perry Hill which must be disconnected before the bridge can be safely demolished.

Additionally, we will also be working to install new electricity cables along this section of Gawcott Road/Perry Hill.

These works are an important step towards the eventual re-alignment of Gawcott Road/Perry Hill over the new bridge, currently under construction.

In order to carry out these works safely and effectively, three sections of Gawcott Road/Perry Hill will be under traffic management. This is for safety reasons, as our operatives will be working in open trenches on and around parts of the carriageway.

When will these works take place?

Two sections of Gawcott Road/Perry Hill will be under 2-way traffic lights from Monday 20 March until early April 2023.

A third section of Gawcott Road/Perry Hill will be under 4-way traffic lights from Monday 27 March until early April 2023.

These dates may be subject to change due to circumstances outside of our control, such as weather.

Duration of works

Two sections of Gawcott Road/Perry Hill will be under traffic management between Monday 20 March and early April 2023.

A further section of Gawcott Road/Perry Hill will be under traffic management between Monday 27 March and early April 2023.

What to expect

2-way traffic lights at either side of the Gawcott Road/Perry Hill Bridge near the entrance of the Great More Sailing Club and near the entrance of the EKFB West Street Compound.

4-way traffic lights controlling the crossroad with Gawcott Road/Perry Hill and West Street.

Varied activities with both quiet and busier periods.

What we will do

Manage any environmental impacts, such as traffic and noise.

Respond promptly to any complaints and take appropriate action.




Where will the works take place?
