WORKS INFORMATION AND NOTIFICATION LETTER: School Hill, Charndon

We are writing to inform you that Buckinghamshire Highways will be carrying out junction widening works at the junction of School Hill with Perry Hill, Charndon (although the works may extend beyond these points). The works will also include installing new signs and road markings, minor drainage works and kerb adjustments.

The works will commence in three phases:

Phase 1: Junction widening works at the junction of School Hill with Perry Hill, Charndon. The works are programmed to take place from Tuesday 28th May 2024, and it is anticipated that the works will take approximately 20 days to complete. The work will be carried out using a road closure, in operation Monday to Friday between 09:30am and 03:00pm.

Phase 2: Upon completion of the junction widening works, we will be undertaking targeted conventional resurfacing at the junction of School Hill/Gawcott Road and Steeple Claydon Road using a road closure.

Phase 3: Once Phase 2 is completed, we will be undertaking targeted conventional resurfacing from Steeple Claydon Road/School Hill junction to Cotswolds Way using a road closure.

We will write to you shortly to provide a further update regarding the programmed dates for the targeted conventional resurfacing.

Information signs and parking suspension signs will be erected on site before work begins, giving actual dates and durations. You will appreciate that works of this nature are extremely weather dependant and therefore may be subject to disruption due to adverse weather. If the works are delayed, the advance information signs on site will be updated to reflect any changes.

Every effort will be made to maintain access for residents within the confines of the closure, although there may be times when it is not safe to do so, and we apologise for any inconvenience. **It is vital that vehicles are not parked on the road and/or footway as this will prevent the works from being completed.**

In the interests of health, safety and welfare, we **cannot guarantee** vehicular access within the confines of the working area. Vehicles travelling along School Hill during site working hours may be subject to **lengthy delays**. Any access arrangements for those who reside within the closure area will be **at the discretion** of our traffic management operatives. Please refer to the advanced warning notices erected on site prior to the works beginning, for work dates and durations.

We apologise for any inconvenience caused.

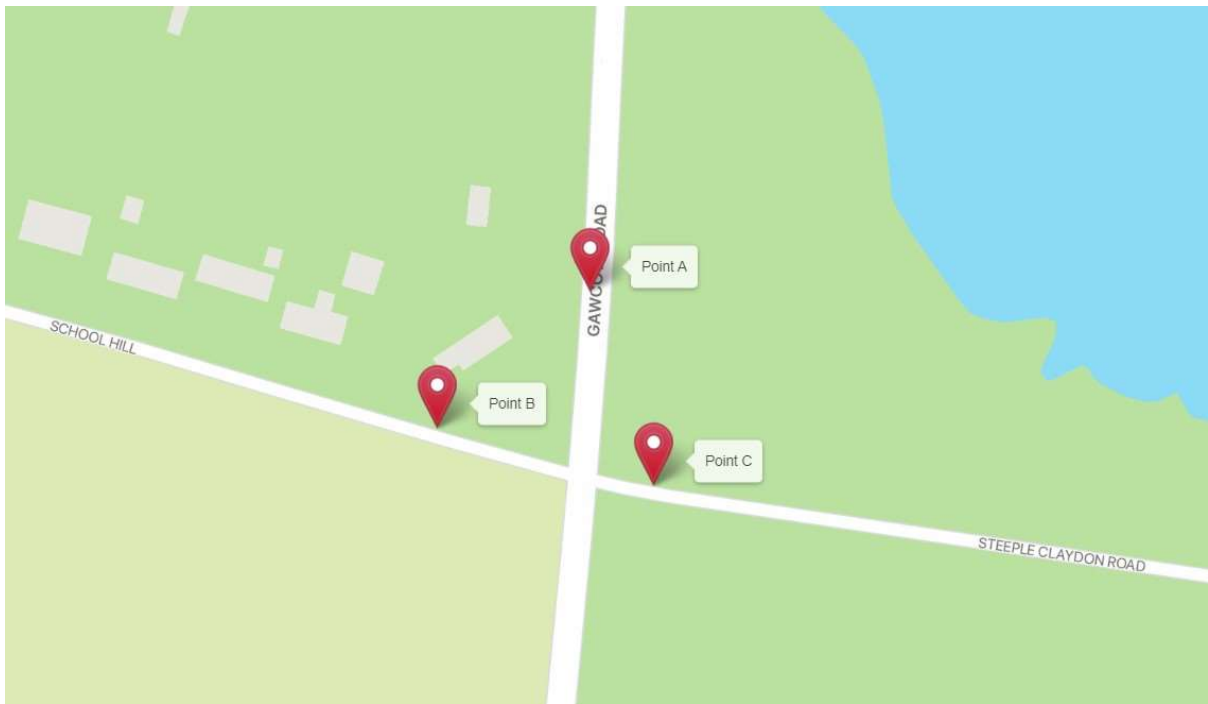
